## 2020 Bobblehead Scavenger Hunt – OFFICIAL RULES

## NO PURCHASE NECESSARY.

**ELIGIBILITY:** The Tennessee Sports Hall of Fame **2020 Bobblehead Scavenger Hunt Sweepstakes** ("Sweepstakes") is open only to legal residents of the United States of America, who have attained their state of residence's age of majority, or permission from their parent or legal guardian, on the date of Sweepstakes entry.
