Full Board Voting Process

Our process will determine 5 At-Large Candidates from a Pool of 13 Nominees

Items B, C and D Expanded

- 1. Presentation Of Candidates
 - a. Brad Willis Will Read A List of At-Large Nominees Listed Alphabetically By Last Name
- 2. Motions Made On Nominees
 - a. Massaro will lead the process of inviting motions to vote immediately on a particular candidate along with discussion and roll call voting.
 - b. Those At-Large Nominees that are not voted upon immediately can be discussed and determined whether further discussion is required.
 - c. Those At-Large Nominees that do require further discussion will ultimately be voted upon via roll call voting.

3. Remaining Candidates

- a. If Initial Candidates Are Not Enough To Fill 5 At-Large Nominees, Further Discussion Will Be Held On The Remaining Candidates
- b. A Formal Vote Will Be Taken On Any Remaining Candidates That Have Been Moved to Further Discussion
