The Tennessee Sports Hall of Fame ("TNSHOF") met this day at 10:00 AM CT for a meeting with a physical location at 312 Rosa L Parks Ave, 13<sup>th</sup> Fl., ERG Conference Room, Nashville, TN 37243 and hosted via WebEx with available call-in numbers. Notice being given seven (7) days prior on the TNSHOF website and Facebook page. The meeting was called to order at 10:05 AM CT by Fulmer. **Financials**, Mahoney, Main item was to point out that the Hall is going in the right direction but will begin to see more expenses due to the banquet. On Exhibit A, \$45,000 pre-paid expenses, Exhibit B, contains the revenue and will see those jump extensively.

#### New Business, Willis

- Honoree Discussion (Unapproved Minutes from Nomination Committee, attached to E-mail invitation). Massaro, The Nomination Committee met for two (2) hours and had great conversations about those athletes submitted. Thank you to the Committee for their participation during the meeting.
  - a. Honorees recommended include:

- b. Olympians, Willis, During the Nomination Committee, the members discuss recognizing Olympians from or with ties to Tennessee. Discussed a scrolling list on a video board during the banquet. Committee members considered whether recognition would be appropriate and capable of being incorporated.
  - i. Discussion,
    - 1. Fulmer, Great idea, but in thinking through how to accomplish could be difficult with three (3) classes going in. Perhaps a predinner slide-show.
    - 2. Ezell, Is someone driving the lack of recognition?
    - 3. Massaro, No one driving, could be a nice layering if the recognition did not add to the banquet length. Could possibility just recognize medal winners.
    - 4. Graeter, Could use names and photo, more recognition. Over the history in Olympic years there was recognition from or with ties to TN. The tradition may have slipped through.
    - 5. Ezell, Could put together a one-page ad in the program but someone would need to be responsible for the accuracy of the list.
    - 6. Fulmer, Will ask Bud Ford to compile listing. Massaro in agreement.
    - 7. Lampley, What about general selection, considering professional wrestling? Also looking at the honoree list, there is not a Coach of the Year category. Consider adopting? Also, dawned on him there is a challenge with college baseball. If a team accomplishing something significant in July then it is stale by the time the calendar comes around next year. Do we have the ability to honor as co-honorees? Willis, Can bring to the Nomination committee agenda.
      - a. Massaro, Considered the final point a lot. If a team wins a national championship, think could have the banquet MC shout out and explain that awards are decided in April and for timing will be considered for next year.
      - b. Lampley, But, if a team wins a National Championship it would never be more timely or relevant than the few weeks afterwards. Adds another level of prominence to have the coach or a few players.

- c. Bradshaw, Consider Circle of Champions as a place holder, as opposed to simply recognition will get an award next year. If it's a good year in sports, may need to vote.
- Golf Tournament Update, Willis, Excited about the return of the golf tournament on June 6 to Vanderbilt Legends Club. Raised 20K, along with hole signage with lunch provided from CapStar Bank, along with post meal and polos for players. If able to attend, let Willis know and working on list of staff and volunteers. Maximum number of teams at 25.
- 3. <u>Banquet Update</u>, Willis, As of today's date, the Hall has raised \$126,000 for the Banquet, this includes thirty-two (32) tables and 335 attendees for the July 23 Banquet. TDTD is assisting with hiring an event planner, Lacy Fusion, for the next three (3) months to help execute the vision. With three (3) years of inductees will need to have as many board members in attendance as possible.
  - a. General Discussion,
    - i. Ezell, Annual reminder, this is a fundraising board and each member should act to give/raise \$5,000.00 and provide connections to Willis.
- 4. TV Special Update, Willis, Mike Keith will be in the Hall and the televised special will air on June 28 in the same six (6) markets that the special aired over the last two (2) years. The televised special will be used as an introduction to the state and hopeful it will drive attendance to the live Banquet. The TN Lottery is tied to the televised special and want to especially thank Fulmer for his assistance in securing the sponsorship for 22-23 and their \$50,000 sponsorship will begin in August. This wraps up the TN Lottery's sponsorship this year and then next year their participation increases.
- 5. Banquet Run of Show Execution, Willis, The Banquet is being promoted as a celebration of the Classes of 20', 21' and 22', and after visiting several Hall of Fame inductions, for example, TN Radio Hall of Fame, the Memphis M Club, and the TSSAA Hall of Fame Willis proposed that none of our inductees speak this year. In structuring it this way, it gives the opportunity to honor all three (3) classes in an expedient fashion, that doesn't diminish anyone's induction. Willis spoke to several inductees and believes the majority would prefer to not have to speak, and in seeing the TSSAA presentation last month, Willis believes the inductees can be honored in a way that feels very fitting and worthy of the honor. Willis would be open to the Tennessean of the Year saying a few words, but with a class of thirty-four (34) inductees over three (3) years, Willis proposed that this format be adopted for this year of no speeches by inductees. Any questions or discussion?
  - a. <u>Motion</u>, Ezell, would take a motion to adopt the proposal as stated by Willis, with second from Campbell and Graeter. Further discussion?
    - i. Lampley, Brilliant idea, suggest to structure like the College Football Hall of Fame and allow one (1) person to give a speech for the entire group.
    - ii. Bradshaw, In Inductees do not want to speak consider allowing them to record a five (5) minute speech that allows them to thank coaches, etc. and then post to Hall's website. Could increase web traffic.
    - iii. Dunavant, Those clips would be great social media posts to keep fresh and relevant. Ask Inductees to provide key, inspiring advice. Would be a great thirty (30) second social.
    - iv. Fulmer, Limit to four (4) minutes to talk about the group and what the Hall and Administrators to thank.

<u>Motion Amendment</u>, Ezell, amended Motion to turn over the final decision on format of the evening to the Executive Director. Second by Graeter. No further discussion. Move to roll call vote:

- 6. <u>Establish Golf & Banquet Committee</u>, Willis, Will not further bog down schedule, but if do not come forward will call you. Want to give time to think and will start reaching out. A lot of heavy lifting will be done by the time get there. Have same things, ideas, how to attack certain things and would love to have a committee for each event.
- 7. <u>Banquet/Hotel Quotes</u>, Willis, Visited the Omni on Tuesday. Have a good plan for ingress/egress and at work to produce signage. Have ten (10) rooms for Friday night, and thirty (30) rooms for Saturday night. Willis working with inductees to allot as many of those as possible for them but know that we can purchase rooms as needed for you for Saturday night.
- 8. <u>Hotel Update</u>, Willis, Secured a courtesy block of rooms at the Marriott Cool Springs for Inductees family members that might not want to spend \$500.00 for a hotel room on Saturday night. Marriott offered us a rate of \$169.00 per night and Willis offering that up to anyone who might need or want those rooms when they have family or friends coming in to support them.
- 9. <u>Predators/Lease Update</u>, Willis, Commissioner Ezell and Willis met a couple of weeks ago with Predators CEO Sean Henry and he was able to confirm that they plan to build on our footprint sometime after June of 2023. Hall has quotes in hand for museum planning that begin at \$19,000 and essentially help us pitch the Hall to possible hosts for a venue, but we have not entered into any agreements with them yet.

<u>Closing Remarks</u>, Fulmer, Thank you for being on the call and the healthy conversation about all that is discussed. Motion to adjourn with second from Graeter. No further discussion, move to a roll call vote.
