Minutes Tennessee Sports Hall of Fame, Development Committee Meeting February 28, 2022

The Tennessee Sports Hall of Fame ("TNSHOF") Development Committee met this day at 10:00 AM CT for a meeting with a physical location at 312 Rosa L Parks Ave, 13th Fl., Nashville, TN 37243 and hosted via Zoom with available call-in numbers. Notice being given seven (7) days prior on the TNSHOF website and Facebook page. The meeting was called to order at 10:02 AM CT by Graeter. Roll was called and a quorum was established, with the following members present.

Welcome and Call to Order. Thank you for being on the call today.

Housekeeping

- Widrig, asked if any guests were on the call that may wish to be recognized. Hearing none, the meeting proceeded.
- Pursuant to T.C.A. § 8-44-108(a)(d), the determination of necessity for conducting the TNSHOF Development Committee meeting electronically was read into the record and rendered as essential to discuss and continue planning for the Hall's 2022 Induction Banquet.

 Approved the November 30, 2021, Minutes of the Development Committee without a reading, as the Minutes were provided to members in advance of the meeting. <u>Motion</u>, by Graeter with second by Wampler. No discussion. Roll call vote.

<u>New Business</u>, Willis, Will go through the five (5) bullet points provided in the agenda, want to discuss each one to offer feedback to gain thoughts on best approach.

- 1. <u>Banquet Pricing</u>, Willis, Would like to go over pricing of banquet tables as are two (2) Inductees away from rolling out the entire class and would like to be able to provide pricing as a complete roll-out.
 - a. <u>2020 Pricing Guide</u>, Willis, Went through 2020 Sponsorship Packages, provided as an attachment to the email meeting request. Would like feedback on whether the pricing is too low or too high, open to conversation but wanted members to have for reference:
 - i. Discussion, Willis, line of thought is to utilize the 2020 price structure.
 - 1. Graeter, In favor of the same pricing, and would also like to discuss Individual pricing.
 - a. Willis, An individual ticket for plated dinner was \$250.00 and then a premium individual ticket for access to VIP reception, plated dinner and two (2) drink tickets was \$500.00.
 - b. Graeter, With program advertising, the full and half pages have been consistent over the past two (2) years despite not having a banquet. Those prices are calculated into the packages as well, so it is all lumped together.
 - 2. Campbell, agree with 2020 price structure.
 - ii. Motion, Graeter, In favor of keeping all pricing the same in addition to what was discussed with second by Campbell. No further discussion, proceed with roll call vote:

- b. <u>Announce Date Next Week</u>, Willis, Working with Lee to finalize last two (2) inductees and once finalize will announce the date of the banquet. Also, working on infrastructure in order to allow purchase through the Hall's website. Hold off on any solicitations until all the information is available to the public.
- 2. Golf Tournament Pricing, Willis, Included within the meeting invite was the 2016 Champion Within Golf Tournament Invitation with pricing. Working with Lee and group at Vanderbilt and have been so kind to donate the greens fees for Monday, June 6. Want to discuss if \$1500 is the proper price point,
 - a. Discussion,

- i. Greater, Is the price for four (4) or five (5) with the foursome hosting the hall of famer/celebrity?
- ii. Willis, Have one (1) flight and that will be in the afternoon, could double stack holes, as many as thirty-six (36) foursomes, so then need as many as thirty-six (6) Hall of famer/celebrities. But, since it will be the first year back think at most would get twenty-four (24) teams.
- iii. Meeting disruption, at 10:18 AM CT, a person joined the zoom call and did not meaningfully participate in the meeting and therefore had to be removed. Following removal, committee business continued.
- iv. Graeter, In talking about numbers, if host a team of five (5) players, what is the market in Nashville for playing on an elite course?
- v. Boring, Unsure where pricing would be for fivesome or foursome with hall of famer/celebrity \$1500 versus a grand or 1300 versus a grand.
- vi. Campbell, Always think best not to charge more than you necessarily need to make the money need, because you don't want to keep people from participating.
- vii. Willis, Old radio station is hosting a golf tournament at Old Natchez, at the rate of \$150.00 per golfer or \$600.00 for a fivesome. And would propose to charge \$600.00 for a foursome and \$1000.00 for foursome + a hall of famer/celebrity. Also considering capping the amount of celebrity groups. Also, need to consider that will be asking for sponsorships on each hole.
- viii. Wampler and Graeter expressed agreement with Willis's proposed price structure.
- ix. Willis, Do not need anything official as Board granted authority to Willis, but wanted to receive feedback.

Willis, This brings an end to official business.

<u>Closing Remarks</u>, Graeter, Appreciate everyone and look forward to the formal announcement. Motion to adjourn by Graeter, with second from Boring. Hearing no further matters to be discussed, move to a roll call vote:
